

## MANAGEMENT OF LIQUOR CONSUMPTION IN THE MOVISTAR ARENA IN BOGOTÁ

The Movistar Arena in Bogotá is a multipurpose space, enabled for agglomerations, which respects the regulations contained in the National Police Code or Law 1801 of 2016 and Agreement 79 of 2003 or the Police Code of Bogotá D.C. Consequently, it is a space for controlled consumption of alcoholic beverages.

In our Arena it is legally allowed to sell alcoholic beverages for the consumption of adults and we ensure that minors are not sold this type of beverage, establishing, for events with minors, areas where the consumption of alcohol is not allowed and the spectators of the respective events are free to decide in which area of the Arena they will witness the public show (location when purchasing their tickets).

The Alcohol Free Zones are defined as areas determined by the Lessor, where the consumption and sale of alcoholic beverages is not allowed. They will be activated for public Events that allow the entry of minors. In principle, they will be petals 206, 214, 306 and 314, but they can be modified by the Lessor, taking into account the characteristics, requirements and population of the respective show.

The following policies of Colombiana de Escenarios S.A.S. - CDE - are mandatory in the Movistar Arena in Bogotá in relation to alcoholic beverages:

### A. Regarding the Sale

1. The sale of alcoholic beverages is prohibited for minors.
2. We reserve the right to sell and market alcoholic beverages.
3. For the sale of alcoholic beverages, the containers destined for this purpose will be used, which are previously authorized by CDE.
4. The different use of glasses or containers for alcoholic and non-alcoholic beverages will be controlled and required.
5. Mechanisms will be designed to avoid forms of deception in the sale of alcoholic beverages, for which CDE will have the power and the right to control and verify the sale of beverages to the general public, by promoters, sponsors, dealers and tenants. These mechanisms may vary from time to time and from one event to another, without prior notice from CDE.
6. Seniors are free to buy alcoholic beverages, but CDE and Venues Snacks officials must control the sale and consumption of liquor, in order to protect users and visitors to the Arena and the environment from the shows.
7. The sale of alcoholic beverages is suspended no later than 20 minutes before the end of the event.

8. Controlled consumption of alcoholic beverages implies avoiding, as far as possible, situations of drunkenness of people and promoting education about the excessive consumption of such drinks.
9. The sale of alcoholic beverages at the Movistar Arena can be suspended at any time according to CDE guidelines.
10. Campaigns are carried out to promote the conditions that favor the safety of shows, training campaigns related to responsible consumption and behaviors that promote coexistence to be transmitted before each event.
11. We have agreements with companies that provide **taxi service** with enough vehicles assigned to the Arena and **drivers** to guarantee the safety of our visitors.

## B. Regarding Consumption

1. Movistar Arena is committed to the responsible consumption of alcoholic beverages.
2. People who have behaviors or symptoms of alcohol poisoning or some difficult, violent or disrespectful behavior can be removed from the Movistar Arena.
3. In the events in which minors are allowed to enter, alcohol-free zones will be established, which will be notified to the Ticket Office so that it offers the public the possibility of purchasing ticket office in one or another sector to enjoy the show. CDE and its accidents will inform consumers (of legal age) the conditions of their consumption and will announce that they will identify certain specific areas.
4. Movistar Arena reserves the right of admission and permanence of the spectators. Those who present behaviors that threaten security, coexistence and tranquility of the general public will be removed from the Arena.
5. The people who make up the Movistar Arena Support and Security Brigades have the obligation, among others, to redirect and attend to people in a situation of drunkenness, provide them with support, medical assistance if required, avoid accidents and situations that affect the assistants, Arena officials, producers and/or artists.
6. The carrying and consumption of alcoholic beverages is prohibited during the entrance, exit or evacuation of the Arena to attend the respective events. Logistics is obliged to confiscate the bottles and glasses that people have during these activities.
7. There is a margin of subjectivity in determining behaviors or symptoms of alcohol poisoning in people. The Movistar Arena and its staff reserve the right to determine when a person is unable to buy or consume alcoholic beverages or remain in the Arena.

8. All the people attending the Movistar Arena are being recorded and monitored. This information will be treated as indicated by current regulations and can be used as proof of the behavior of the attendees.

9. The sale and/or consumption of alcoholic beverages in the public space surrounding the Movistar Arena is completely prohibited.

#### C. Of the Procedures

1. The security of the Movistar Arena is in charge of CDE, the operator of the Arena, which will make available to the attendees a security team and support brigades to comply with CDE policies and current regulations, in addition to its private security team.

2. The National Police empowered the security team of the logistics operator of the Movistar Arena to comply with the regulations contemplated in the National Police Code.

3. The security team and support brigades are trained and have among their functions to comply with these Regulations and the applicable rules of the National Police Code, for which they may request support from the National Police.

4. During the events, the National Police will have a presence in the Arena with an immediate reaction team, to attend police and coexistence situations that require their intervention.

5. People who affect the smooth running of events with inappropriate behavior, alter the coexistence, recreation and safety of the attendees or themselves, will be removed from the Movistar Arena.

6. The Movistar Arena may veto the entry of repeat offenders in conduct that threatens the proper conduct of events, the safety of the general public or against themselves.

7. CDE employees or those of its dealers who support or induce non-compliance with any aspect of these Regulations, the National Police Code or the Code for Children and Adolescents will be removed from the Arena and subjected to the respective disciplinary process from their employers.
